Patient Sample and Test Mode Dates

- **Patient Sample** will be available on Monday, January 8, 2018. Quality Analytics will process the sample and create each QRO's sample file to abstract as well as the QRO Provider Contact Sheet. Once complete, it will be sent out to the CMS Web Interface QRO Contacts list via MiShare.
- **CMS Web Interface Test Mode** will be available on Monday, January 8, 2018. You are more than welcome to access it and review it. Cana and I will review it together and create an agenda for discussion for the Tuesday, January 9, 2018, CMS Web Interface Reporting Tool Review Session. The test mode period is January 8–19, 2018.

Immediate Action Required: EIDM Account and Role Set-up

The CMS Web Interface (CMS WI) will be open for PY 2017 data collection starting Monday, January 22, 2018, and will close at 8:00 p.m. Eastern Time on Friday, March 16, 2018. In order to participate in CMS WI quality reporting for PY 2017, ACOs must set up the necessary Enterprise Identity Management (EIDM) accounts and roles. ACOs are encouraged to set up these accounts and roles as soon as possible so that they will be ready when the CMS WI opens.

Check your access!

- If PY 2017 is your ACO's first year in the Shared Savings Program, then your ACO

must set up EIDM accounts and roles to be able to access the CMS WI for reporting.

- If your ACO participated in PY 2016 quality reporting and users maintained active passwords, accounts, and roles, then your users should not need to set up new accounts or roles. If user accounts are no longer active, please contact James Malayang.
